- Rob Wasserman Suggestions:
  - Helmet Requirements for all paid and volunteer coaches: Tabled for next meeting **Motion** - To revote that all paid coaches/staff and volunteers when skiing in program events are required to wear a helmet. Those who do not will be warned and eventually ski pass turned off for repeat offenders.

### Background

The board of directors voted back 4-5 years ago that all paid coaches and volunteer coaches are required to wear a helmet. There is some long standing history here in which a Junior Coach fell and hit a tree wearing a helmet, and the helmet saved her life. Over the past two seasons I have personally witnessed coaches from our Devos and Mighty Mite programs not wearing helmets on the weekends. Our volunteers are role models to the athletes and should be wearing helmets to set a good example.

 Program, one representative of the Alpine X program, and one representative of the
 Masters Program. These programs are defined by the Alpine Committee and the
 representations listed are minimums. Other programs of the Alyeska Ski Club shall also have representation proportionate to participation by athletes. The intention of the
 board make up shall be to give each program fair and proportional representation on the Board of Directors."

## Background

The attached meeting notes is from July 11, 2016 board meeting, the last time the bylaws were reviewed based on number of board members and program representatives. I believe as the freeride and devos programs have grown and the introduction of Alpine X we have failed to update to board of directors for equal representation for these programs. Note, at the time the board was disproportionate to various programs so the board set up a plan on how to right size the board and member program representation. Current Bylaws Section 3.03

The Board of Directors intends to maintain a Board Member composition of two representatives of the Juniors Program, two representatives of the Mighty Mites Program and two representatives of the Masters Program. These programs are defined by the Alpine Committee and the representations listed are minimums.
